Clarion River 2019 PA River of the Year Celebrations Slated Across Region

A true tale of a river's remarkable ecological resiliency can be found right in our backyards here in western Pennsylvania. The Clarion River, a federally-designated National Wild and Scenic River, has now also been designated the 2019 Pennsylvania River of the Year. The general public was invited to vote online from November—December, 2018, choosing from among four waterways nominated across the state. At the conclusion of the public voting campaign, the Clarion River was the clear winner, tallying nearly 40% of the more than 14,700 total votes cast.

In cooperation, with the Elk County Conservation District and Allegheny Watershed Improvement Needs (WINs) Coalition to nominate the Clarion River for Pennsylvania's 2019 River of the Year, Western Pennsylvania Conservancy, a registered 501(c)(3) charitable organization, will serve as the fiscal agent managing sponsorships and a leadership grant from the PA DCNR and the PA Organizations of Watersheds and Rivers (POWR) to help plan and celebrate the River of the Year designation. A free, commemorative poster celebrating the Clarion River will be unveiled at a canoe sojourn event planned in June. The nominating partners will coordinate with many other organizations to manage the 2019 River of the Year celebration over a large geographic area to host educational, recreational, and stewardship events connecting residents and visitors, alike, to the value of clean water and the resources provided by a high quality stream, such as the Clarion River.

As part of the 2019 PA River of the Year Celebration, partners will be co-sponsoring a series of public events to be held in various locations from the source of the Clarion River's East and West Branches in Elk and McKean County all the way downstream to its confluence with the Allegheny River near Foxburg and Parker, Clarion County. The pinnacle event highlighting the celebrations will be a 2-day canoe sojourn from Hallton to Cooksburg June 22–23, 2019. From the River of the Year grant awarded by PA DCNR and POWR, the nominating partners will be offering a mini-grant program to co-sponsor River of the Year events in communities all along the Clarion River corridor and its watershed. The River of the Year grant requires us to provide local cash match to those funds and there are limitations on what the grant funds can be used for, so we are searching for additional partners who would be interested in co-sponsoring the River of the Year Celebration events.
